Example One

Mr Smith lodges a Request for Information from Records. On the form he has selected the Abstract of Records and would like to know all known sites that fall within 3 mining tenements.

What will be the cost to Mr Smith for this request?

	Revenue Units (RU)	Value of Revenue Unit (VRU)	Cost (RU x VRU)	Quantity (mining tenements)	Total (cost x quantity)
Application	23	\$1.18	\$27.00	3	\$81.00

Total: \$81.00

Example Two

Company Coffee Beans lodges a form Request for Information from Records. On the form the company has selected the Abstract of Records and would like to know all known sites that fall within 2 mining tenements and 4 NT Portions (NT Portion 22, NT Portion 21, NT Portion 57, NT Portion 300).

What will be the cost to the Company for this Request?

	Revenue Units (RU)	Value of Revenue Unit (VRU)	Cost (RU x VRU)	Quantity (mining tenements)	Total (cost x quantity)
Application	23	\$1.18	\$27.00	6	\$162.00

Total: \$162.00

However, upon investigation it is found that there are many known recorded sacred sites within the requested areas which are not easily seen on a small map and the company decides that larger maps will be desirable to show all the information. The company requests maps larger than A3 for each of the tenements and portions. So what will be the new cost?
